MINUTES OF STEERING COMMITTEE MEETING FOR 1970 PROVINCIAL CHAPTER

The Steering Committee for the 1970 Provincial Chapter met at the Provincial House on Friday, January 30, 1970, at 7:30 P.M. All members were present. The following decisions were taken at the meeting:

- 1. A summary of the Steering Committee meetings will be placed in the Midwest News Notes
- 2. The Steering Committee will propose the following appointments to the Chapter for final approval:  
Moderator: Brother James Sullivan  
Capitulant Secretaries: Brothers Jeffrey Michels and Carl Shonk  
Non-capitulant Secretaries: Brothers Evan Schmid and Sigismund Danielski  
The assistant moderator will be proposed later
- 3. The committee decided to propose to the Chapter that legislation take the following forms: a) decrees; b) recommendations; c) statements  
 Explanations of these various forms will be given to the committee members in the very near future.
- 4. The matter of consultation of Province members was discussed at some length. It was unanimously approved that the following directive be issued to all Chapter committees:  
 Regarding consultation of province members, if the visitations to the houses are not made personally by members of the committees, then some other method (such as bulletins, surveys, individual correspondence, etc.) should be utilized.
- 5. Brother Pedro announced the results of the elections whereby the temporarily professed of the Province voted for temporarily professed consultants to the Chapter. Those elected were the following: Brothers Eugene Hausmann, Bruce Lescher, Paul Brown, and Joseph Cernick. The Provincial appointed Brother Joseph Thilman as the fifth member. These Brothers will be appointed to Chapter committees, will have the right to participate in deliberations of the committees and speak on the floor of the Chapter, but will not have the right to vote on Chapter decisions. The Steering Committee approved these Brothers.
- 6. Some attention was given to preventing over-lapping of the agenda of the various committees. To prevent this, Brother James Moroney was directed to see that the agendas of the various committees are exchanged among the committee chairmen. All chairmen are asked to see that Brother James has up-to-date copies of each committee's agenda as soon as possible.
- 7. The Steering Committee voted unanimously that all Chapter committee meetings be open to anyone in the Province interested and able to attend.
- 8. The next meeting of the Steering Committee will be held immediately prior to the April session of the Provincial Chapter unless there is a need to call a special meeting at an earlier date.

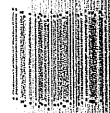
