Fulgence Dougherty, recovering from an operation, will likely depart for Bangladesh in February. . . . Br. Terence Muehlenkamp's return there from the States will be delayed several months.

A tentative agenda for the general chapter was drawn up at the Pineville meeting. Father General intends to publish a circular letter about this tentative agenda.

FROM THE SOCIAL JUSTICE COMMISSION

Four meetings have been held by CSC priests, sisters, and brothers since November to explore the possibilities of a joint project for the South Bend area. Next meeting is scheduled for January 8.

Did you know that

Over 100,000 political prisoners are in South Vietnam prisons and that U.S. personnel and funds are used for the support of these prisons.

\* \* \* \* \*

A 74.1 billion dollar military budget has been approved by the House Appropriations Committee. There are, however, to be supplemental appropriation requests for \$2.2 billion to cover pay increases put into effect last January, and a further \$3 billion to cover stock-iling weapons and increasing the number of cargo planes the military says are necessary because of the Israeli-Arab conflict. With these, the military budget appropriation bill will be \$7.7 billion greater than last year. In addition a separate bill in the amount of \$2.2 billion was passed for military aid to Israel.

Atlantic Richfield Oil earned \$797 million in net income in the years 1962 through 1968, yet paid NO federal tax in the first six years of that period and only 1.2% in the seventh year.

The 27.5% oil depletion allowance given to the oil industry (it was changed to 22% in 1969) deprives the Treasury of more than a billion dollars a year in taxes.

General Motors has an annual revenue greater than that of any foreign government except the United Kingdom and the USSR.

\* \* \* \* \*

In 1970 the Farm Subsidy Program of the federal government made grants of more than \$100,000 each to 415 farm owners (major corporations, banks, large landowners). Among these were Sen. James Eastland who received about \$160,000, and John Wayne and partners who received \$810,000. Nine companies received more than \$1 million each. In California: Griffin, Inc. \$4,095,114; Vista Del Llano Farms, \$1,105,762; H. M. Tenneco, \$1,317,051; J. G. Boswell, \$4,429,484; South Lake Farms, \$1,875,454; Salyer Land Co., \$1,547,174. In Florida: U. S. Sugar Corp., \$1,073,980. In Hawaii: Hawaiian Com. and Sugar Corp., \$1,232,166; Waialua Sugar Co., Inc., \$1,111,060.
