
appreciate receiving word on why you think so and their contact information so that we can consider a more assertive recruitment approach to them.

#### Position Opening:

The Executive Director of Student Financial Strategies focuses on objective, research-based ways in which student financial aid can be optimally utilized to meet the University's goals and objectives with regard to recruiting and retaining a highly qualified and diverse student population. Develops for and presents to senior leadership recommendations leading to the achievement of long-term goals.



In collaboration with the associate vice president and University Relations, fosters the creation of additional scholarships, whether by annual giving or endowments, and cultivating positive donor relations.

The Executive Director leads a staff of 30+, including four associate directors primarily responsible for routine operations, to assure proper administration and stewardship of all resources used in financing a Notre Dame education.

Commensurate with Notre Dame's standing and interests, the Executive Director represents the University to government and regulatory audit agencies and organizations, offers recommendations and guidance to other stakeholders, such as academic deans and alumni clubs, and participates in and leads related professional organizations.

Works collaboratively with the other directors, all of whom report to the Associate Vice President of the Enrollment Division.

#### Minimum Qualifications

The right person will have a résumé that necessarily includes (1) having demonstrable success in evaluating and strategically leveraging current trends in student financial aid and enrollment management; (2) a good balance of working knowledge in areas of scholarship administration (need-based and merit), loan administration, and student accounts (bursar); and (3) verifiably successful leadership of a staff of at least 15.

#### Preferred Qualifications

Current or recent leadership in related professional organizations is highly desirable, for it suggests peer awareness and appreciation of ability, skills and achievement.


A master's degree is preferred, desirably in finance, higher education administration, or business administration. (Others may satisfy, depending on experience.)
